OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
A VALID EMAIL ADDRESS IS REQUIRED.**

- 1. ELIGIBILITY:** The COMBOS Finishers Promotion (the "Promotion") is offered only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older at the time of entry. Void where prohibited or restricted by law. Employees, officers and directors, and their immediate family members (spouses, siblings, parents and children, including foster and step-relations, and their respective spouses) and household members (whether or not related) of Mars Wrigley Confectionery US, LLC ("Sponsor"), Prize Logic, LLC ("Administrator"), The Integer Group, World Wrestling Entertainment, Inc. - 3.
